








Photo n°22: Rooftop plantings at "**Place du Portage III and IV**", Gatineau, QC




Photo n° 24: Example of concept design sketch prepared for Municipal Review.




Photo n° 26: Example of a landscape concept plan prepared for the core activity area.




Photo n° 27: Example of freehand design sketch.




Photo n° 28: Example of preliminary overall "bubble" concept plan.


